to speak with Sherry Monack. Mr. Monack told me to come inside the residence. Mrs. Monack was sitting on the couch watching television and I asked her if she was Sherry Monack; Mrs. Monack advised me that she was. I advised Mrs. Monack that I had a Warrant for her Arrest from Buncombe County for Misdemeanor Breaking and Entering. Mrs. Monack laughed and stated that this must be a joke. Mr. Monack asked if this was a joke and I stated that it was no joke. Mr. Monack and I stepped outside and he stated "Do you know who I am?" I stated no sir. Mr. Monack stated that he was Commissioner Monack and a retired Army Lieutenant Colonel. He also stated that his wife is an active Lieutenant Colonel in the Army. Mr. Monack asked if this could be somehow taken away because it was all a big misunderstanding. I advised Mr. Monack that once a Warrant is issued it must be executed. Mr. Monack wanted to speak with the Buncombe County Magistrate. I retrieved the number for Mr. Monack as Mrs. Monack changed her clothes inside the residence. Mr. Monack spoke with Buncombe County Authorities and after speaking with them, understood that I had to take Mrs. Monack into custody. I placed Mrs. Monack under arrest and transported her to the Lee County Sheriff's Office for processing. Mr. Monack followed and waited in the Magistrates Office. I then took Mrs. Monack before Magistrate M R Cole which issued a written promise to appear to the Buncombe County Courthouse Courtroom # 3 in District Court on August 2, 2011 at 08:30hrs. Mrs. Monack was given copies of her legal paperwork and released. Nothing Follows.
